Bids for the roof: There is enough money in the account to begin seeking bids for the work. Next month, the board will review the specs drawn up several years ago by UP Engineering. The cupola and end gables will be included in the work. It was suggested that future Bridgefests could help finance the project.

The board decided that belonging to a cemetery search engine was not necessary, but will suggest to those seeking information where information is available.

Motion by Treganowan, seconded by Long, that board members be authorized to attend the June 5th MTA meeting, with expenses paid by the board. Motion passed unanimously.

Board authorized clerk to order the set of books from MTA which are guides to each of the elected positions.

The next fiscal year (2013-2014) were set for the third Monday of each month.

It was decided to maintain the Museum Savings Account.

The township rental agreement was distributed to each board member, and will be reviewed at later meetings.

Water System Repairs — A leak was brought to Mel's attention by Gary Erickson. This was the third time for this problem in the same area. A brass pipe replacement was used this time, and should be more durable. Siler, Inc. will bid on the tank replacement project, and a plan will be given to Doug Pasco in August.
