Bridge – plan for future work: straighten railings; replace some steel below the bridge, and install structural angle steel. Two contractors were invited to bid for the job, with only one response – McMahon Excavating bid \$3850 for this work. Motion by Treganowan to hire McMahon Excavating to begin the work as soon as possible. Seconded by Chase. Motion passed unanimously.

When the concrete work is done next, it will be what is used on ice rinks.

BUDGET REVIEW

Motion by Treganowan, seconded by Long, to increase School and Education (Water Fund) from \$180 to \$230. Motion passed unanimously.

Motion by Long, seconded by Treganowan to increase Supplies (Water Fund) from \$400 to \$1200. Motion passed unanimously.

Motion by Long, seconded by Treganowan, to increase Facilities and Equipment (Bridge Fund) from \$400 to \$450. Motion passed unanimously.
