- ♣ It was noted that the Zoning Board of Appeals denied the abandonment of right of way on Front Street, enacted by the Road Commission.
- Land reverts back to the township when abandoned
- ♣ New construction was deemed safe
- ♣ Abandonment may cut off future uses
- Precedent set?
- Challenge not issued until construction was 90% completed

Houghton Township will decide at the regular meeting on May 20 to either refrain from disclaiming the abandoned right of way, in which case the right of way would revert to the Road Commission pursuant to the Road Commission resolution or the Township Board will disclaim the right of way and allow abandonment to go forward.
