Motion by Treganowan, seconded by McEvers, to approve the consent agenda, with minutes as corrected. Motion passed unanimously.

OLD BUSINESS -

Motion by Treganowan, seconded by McEvers, to allow the use of the community building by the Keweenaw County Historical Society at no charge for a volunteer appreciation event. Motion passed unanimously.

Rental Agreement – Final revised copy to be presented next month for adoption

<u>Green Burial</u> - Motion by Long, seconded by McEvers, to table discussion of green burials. Motion passed unanimously. <u>Painting</u> –Jack and Mel will begin planning for the painting project. A HiLo will be rented.

Motion by McEvers, seconded by Chase, to proceed with the painting of the building with Mel and Jack overseeing the project, and to purchase paint and incidental supplies, to rent the HiLo and to oversee its operation. Motion passed unanimously.

NEW BUSINESS - Jm Vivian reported on a proposed land swap by the state, exchanging 320 acres of Houghton Township land for 80 acres in Grant Township. The land would be taken off the tax rolls.

Motion by Treganwoan, seconded by Chase, that a letter be sent stating that we are not pleased that the township was not notified of the land swap, and don't think that it would benefit our Township, the county, or the state to make this swap. Motion passed unanimously.

Summer tax bills to be sent out soon. <u>CLERK'S REPORT</u> - Motion by McEvers, seconded by Long to fund clerk's attendance at MTA workshop for \$300. Motion passed unanimously.
