WATER DEPARTMENT REPORT – Water pumpage has increased to over 15,000 gallons a day from the usual average of 4,600 gallons a day. The community was asked to help locate the leak by reporting if they notice any extra water coming out of the ground.

OLD BUSINESS -

- ❖ Pavilion update Following up on a suggestion made at the March regular meeting, the park committee discussed a change of layout for the pavilion. The majority of the members decided to keep the layout as outlined in the engineer's plans. The plans are now set for bids.
- A work day to review the proposed Township Square Park Ordinance and the Township Credit Card Use Policy will be set when meeting restrictions are lifted.
- ❖ Placement of Dumpster Dave and Mel will continue to look for potential sites.
- **❖** NEW BUSINESS -
- The following actions were taken by the board in order to comply with state (Michigan Executive Order No. 2020-42) and federal health mandates:
 - 1. The public restrooms and playground will be closed until further notice, with signage posted at the locations as well as on the Website.
 - 2. Motion by McEvers, seconded by Jones, that the board adopt a resolution that all water turn-ons be suspended until April 30, at which time the resolution will be reconsidered. Motion passed unanimously.
- ❖ Fire Protection Motion by Long, seconded by McEvers, that Houghton Township retain the services of Allouez Township Fire Department, and continue the annual payment of \$5000. Motion passed unanimously.
- ❖ Motion by Long, seconded by McEvers, that the treasurer be authorized to continue to transfer \$125 per month from the General Fund to the Savings Account. Motion passed unanimously.
